OPEN CALL for the submission of project proposals aimed at the definition of the PUGLIA SOUND
RECORD 2022 YOUNG & SENIOR PROGRAMME

1 - PREAMBLE

In order to lay down its own cultural development strategy and related actions intended to enhance, innovate and promote its entire cultural system through well-established action priorities, Regione Puglia (the Regional Government of Puglia) has started the development of a strategic plan of culture for Puglia 2017-2025, PIIL – *prodotto, identità, innovazione, impresa, lavoro* (product, identity, innovation, enterprise, work).

Now, in line with the content of the above strategic plan, Regione Puglia and TPP (Consorzio Teatro Pubblico Pugliese) have subscribed to a collaboration agreement in a view to enhancing, revamping and promoting the system of cultural events/activities and live shows with a special focus on the Puglia music system by providing music operators with the right tools to expand and qualify cultural demand while upgrading their own offer by improving their artistic and professional capacities, as well as their position and competitiveness on both the national and the international music scene. This set of activities is intended to promote the “cultural system” and hence the tangible and intangible heritage of Puglia. Following the further extension of the resolution published on 31.01. 2020 by the Italian Council of Ministers entitled "Declaration of the state of emergency arising from the health threat related to the onset of conditions caused by transmissible viral agents", the Puglia Region has extended the adoption of a series of urgent measures to deal with the COVID-19 epidemiological emergency, including a Special Support Plan for Culture entitled "CUSTODIAMO LA CULTURA IN PUGLIA".

This Plan is specifically targeted to the following sectors: tourism, cultural and creative industries (CCIs), entertainment companies, filmmaking and audiovisual industries. The objectives of “CUSTODIAMO LA CULTURA IN PUGLIA” (Cultural Heritage Stewardship), which is the result of a co-planning effort shared by the “Department of Tourism, Economy of Culture and Territorial Development” of the Puglia Region, Teatro Pubblico Pugliese (TPP) and the Apulia Film Commission Foundation (AFC), include, among other things, the implementation of a series of specific actions by the two partners (TPP and AFC) of the Department of Tourism that share the objective of supporting the cultural and entertainment businesses and operators of Puglia (publishing houses and audiovisual companies included), as well as the businesses that operate in the sector of travelling shows and, more generally speaking, the entire Cultural and Entertainment System of Puglia, including the businesses having community development and enhancement as their mission.

Within the Puglia Sounds program, the program of the Puglia Region for the development of the regional music system, a set of actions have been defined, including the line of action Puglia Sounds Plus, which are aimed at continuing the actions to support the growth, the consolidation and the distribution of the music offer, as well as to support the growth of music business providing these latter with all a series of tools , including economic instruments, management procedures, know-hows, relationships and experiences that are fundamental to strengthen the capacity of the "Sistema Musicale Puglia" to operate in domestic and foreign markets, as well as to consolidate its competitiveness, even at this time of global crisis of the system as a whole.

These actions are funded by POC Puglia 2007-2013. ACTIONS "DEVELOPMENT OF PERFORMING ARTS AND CULTURAL ACTIVITIES".

The Puglia Sounds Program, entirely focused on the development of the Puglia music system intends to design and deploy projects that involve the entire music chain (from artists/performers to music managers/publisher, to booking agencies, to publishers, to labels, to distribution, to communication, and music consumption) through the action "Puglia Sounds Record 2022 young & Senior" aimed, among other objectives, to promote the marketing and distribution on the national and international market of new record releases from Puglia.

2 – SCOPE AND OBJECTIVES

By the present Call, Puglia Sounds–TPP, in line with what specified above, intend to implement the programme "Puglia Sounds Record 2022 Young & Senior" to promote the creativity and musical cultural heritage of Puglia and therefore the overall attractiveness of the region. To this end, Puglia Sounds–TPP intend to carry out a survey of original projects of creation, production and promotion of new record releases that fulfill the requirements specified below (see SECTION 3 - ELIGIBILITY OF PROJECTS)

The objectives pursued aim to implement the regional cultural offer and production, promote the image of Puglia as a cultural, promotional and productive landmark for artists, companies, producers and institutions with a view to fostering a virtuous match between music and the market, which is essential to promote and enhance artistic professionalism, to promote new business models, to spread the knowledge of music, to diversify the musical offer, to build new artistic and cultural capacities and skills, and to favour multicultural dialogue.

The projects submitted and assessed as eligible under the present Call will be included in the "**parco progetti**" ("folder of artistic-cultural music projects"), on which an *ad hoc* appointed Jury of experts will draw to plan the creating, promoting and distributing new record productions "Puglia Sounds Record 2022 Young & Senior", programming to be implemented in the period between April 25, 2022 and July 31, 2022.

3 - ELIGIBILITY OF PROJECTS

New record production, promotion and distribution projects promoting the Puglia's regional music system are eligible under the present Call.

“Record release” means a record project with a minimum duration of 20 minutes.

The projects proposed will be considered **YOUNG** for solo artists born on or after January 1, 1992 or for music bands in which all members were born on or after January 1, 1992.

Music bands made up of three or more members may include in the project an artist born before January 1, 1992.

Those project proposals that do not meet the YOUNG requirements will be categorized as SENIOR.

The projects proposed will be considered **SENIOR** for solo artists born before January 1, 1992 or for music bands in which all or part of the members were born before January 1, 1992.

Project proposals will be considered eligible if they spread the Puglia's music culture by creating, promoting and distributing new record productions with the following characteristics:

1. be published between April 25, 2022 and July 31, 2022.
2. have a minimum duration of 20 minutes;
3. have no more than 20% of tracks already published, in physical or digital format, at the date of this Call, on the total number of tracks, with the exception of the projects programmed under the Puglia Sounds Producers Call;
4. be printed in at least 400 copies on CD or vinyl or at least 400 copies between CD and vinyl.

The project proposals must also include:

1. the production and distribution of a music video clip inspired by the new record project;
2. publication of the video clip on a digital platform;
3. digital distribution of the record project on a digital platform;
4. the establishment of a Press Office and/or Social Media Management and/or Digital Strategy service.

Please note that the record productions in question cannot be compilations. A compilation is: a record release containing tracks, each of which performed by a different artist/band and previously released, or recordings containing tracks performed by a single artist/band, which have all been released previously on different albums.

Each Applicant is allowed to submit, for the deadline indicated below (Section 5), one only project proposal related to a given artist/band. Should more than one proposal related to the same artist/band be submitted (even by different Applicants) for the same deadline, only the first, on a first-come, first-served basis, will be admitted to the present selection process.

The artists involved in project proposals assessed as ineligible may be included in project proposals to be submitted for other deadlines.

4 - ELIGIBILITY OF APPLICANTS

Original projects for the creation and promotion of new record productions, provided that are in line with the requirements set out in Art.3 here above (Eligible Projects) may be submitted by regional, national or international Applicants established in any legal form who meet the following requirements:

1. holding a VAT number including NACE Code 59.2...; for non-European Applicants: being music publishers or record labels;
2. complying with current labour legislation and collective labour contracts in force in the country of origin of the Applicant;
3. having no arrears in the payment of social security contributions to National Social Security;
4. not to be in any of the conditions of exclusion from participation in calls for proposals pursuant to art. 80 of Legislative Decree no. 50/2016 Codice dei Contratti.

Failure to meet just one of these requirements will result in exclusion of the project from the selection process.

5 - PROJECT PROPOSAL SUBMISSION TERMS AND CONDITIONS

The Applicants specified in Section 4 shall submit their project proposals by sending them **only and exclusively** from a certified e-mail account (PEC in Italian) to the address pugliasounds.record@pec.it with **"Project Proposal Puglia Sounds Record 2022 YOUNG - and indication of the deadline and of the name the Applicant"** in the Subject line or **"Project Proposal Puglia Sounds Record 2022 SENIOR - and indication of the deadline and of the name the Applicant"** in the Subject line, by the following deadline:

- **by 13:00 on Monday 04 April 2022** for the new record productions to be released in the **period from 25 April 2022 to 31 July 2022**;

The Project Proposal:

- must be submitted by exclusively completing the attached form in all of their sections, complying with the number of characters indicated and **in any case without attaching any extra documents when not expressly requested. Forms must be sent in PDF format**;

- in order not to be excluded from the selection process, it must be signed in all of its parts the Legal Representative of the Applicant;

Moreover, in order not to be excluded from the selection process, the Project Proposal must also contain the following:

1. self-certification (non attested affidavit) in place of an attested affidavit, submitted by completing the attached form and signed by the Applicant's Legal Representative, attesting to possession of the eligibility requirements as described in section 4 "Eligibility of Applicants" of the present Call (Form 1);

2. **official certificate of VAT registered details of the Applicant's and/or an updated copy of the Chamber of Commerce company registration report including the Applicant's NACE Code 59.2... or equivalent documentation for Applicants based abroad;**
3. **PROJECT** drawn up using the Forms attached hereto and duly signed by the Legal Representative, containing information as indicated in section 1 above;
4. **An mp3 audio file containing a least 2 (two) pieces (also test recordings) to be included in the new music production proposed hereunder;**
5. **RECORDING CONTRACT OR TRUE COPY OF PRECONTRACTUAL LETTER OF COMMITMENT signed by the Applicant and the artist/band;**
6. **Press officer Contract and/or external Press Office and/or Social Media Management and/or Digital Strategy Contract; If the Press Office and/or Social Media Management and/or Digital Strategy activities will be carried out by the proposing subject "In House", attach a declaration signed by the Legal representative;**
7. **Copy of currently valid identity document of the Legal Representative of the Applicant;**

NB: all documents must be sent in PDF format except for .mp3 audio files.

Please note that for Italian Applicants TPP/Puglia Sounds shall proceed to direct checks of compliance with payment of social security contributions.

Each Applicant may submit **ONE project proposal YOUNG and ONE project proposal SENIOR.**

Puglia Sounds-TPP reserves the right to request the original documents attesting to the truthfulness of data and information contained in the Project Proposal, and also to discontinue examination of the application until expiry of the time allowed to the Applicant for presentation of the original documents requested. If the documents are not presented before this deadline, the Project Proposal will be automatically excluded from the selection process. Puglia Sounds-TPP reserve the right to carry out verification, including test-checks, in order to ascertain the truthfulness of the statements signed by the Applicants.

6 - AVAILABLE RESOURCES

As part of the resources available for the implementation of the intervention POC Puglia 2007-2013. ACTIONS "DEVELOPMENT OF PERFORMING ARTS AND CULTURAL ACTIVITIES", a total budget of **€ 147.620,00** (VAT included) (*euroonehundredfortyseventhousandsixhundredtwentypointzerozero*) has been allocated to "PUGLIA SOUNDS RECORD 2022 Young & Senior" .

The present Call aims to provide for programming of a total:

06 "YOUNG" production, promotion and distribution of new record publications;

13 "SENIOR" production, promotion and distribution of new record publications.

For each **“YOUNG”** project proposal included in the **“Puglia Sounds Record 2022 Young & Senior”** programme a contribution of **€5000,00** (eurofivethousandpointzerozero) will be awarded, plus VAT, if due by law;

For each **“SENIOR”** project proposal included in the **“Puglia Sounds Record 2022 Young & Senior”** programme a contribution of **€7000,00** (euroseventhousandpointzerozero) will be awarded, plus VAT, if due by law;

Puglia Sounds-TPP reserve the right to modify the number of projects to be implemented the basis of the projects submitted.

By the same token, TPP reserve the right to supplement the budget made available under the present Call for programming " PUGLIA SOUNDS RECORD 2022 Young & Senior " with other funds, should further resources become available.

Should the same artistic project also be submitted for participation (even by other Applicants) in the calls for proposals published by Puglia Sounds Producers, Puglia Sounds Record and Puglia Sounds Tour Italia, Puglia Sounds Export, the TPP- Puglia Sounds shall award a total amount of € 15,000 (excluding VAT) for the creation, promotion, record production, distribution and programming of said project

7 – ELIGIBILITY CHECK

The eligibility of proposals submitted will be checked in terms of the following:

- compliance with legal and formal requirements;
- compliance with submission deadline;
- compliance with the requirements set out in the Call for proposals relating to the Applicant and the proposed project;
- completeness of the required documentation.

Those projects considered eligible will be included in the **“Parco Progetti Puglia Sounds Record 2022 Young & Seniors”** (Projects Folder).

It remains understood that the inclusion of a project in the “projects folder” does not entail any obligation on the part of Puglia Sounds-TPP to acquiring/programming the project in question.

8 - ASSESSMENT AND DEFINITION OF THE “PUGLIA SOUNDS RECORD 2022 YOUNG & SENIOR” PROGRAMMING

A Jury appointed by Puglia Sounds-TPP will be tasked with making a selection of the Project Proposals and defining the **“Puglia Sounds Record 2022 YOUNG e SENIOR” Program** on the basis of the evaluation criteria listed below. It remains understood that only projects with a score of at least 12 points for each of the following criteria shall be admitted:





1. **curriculum vitae of the Applicant** (drawn up using **Project #1** of maximum 1,000 characters);
2. **curriculum vitae of the artist/music group** (drawn up using **Project #2** of maximum 1,000 characters);
3. **project of record making and production and communication and promotion campaign plan** (drawn up using **Project #3**);
4. **art project** (drawn up using **Project #4**).

Each one of these criteria will be given a 0-to-20 score.

The score shall be attributed in terms of compliance with the following parameters **on the basis of a qualitative judgement indisputably expressed by the Jury** with specific reference to the level of fulfilment of the objectives hereunder. The “non-evaluabile” score will be given to the Projects Proposals that are in no way in line with the objectives hereunder:

20 excellent
18 very good
16 good
14 fairly good
12 sufficient
6 insufficient
0 non-evaluabile

Any assessments made by other Commissions appointed by TPP/Puglia Sounds for other calls and/or public notices published previously will have no impact on the evaluation process of the present Call.

9 - CARRYING OUT “PUGLIA SOUNDS RECORD 2022 YOUNG & SENIOR” PROGRAMMING

The Applicants, whose Project Proposals will be included in the programming “Puglia Sounds Record 2022 Young e Senior” shall be invited to subscribe to a contract whereby they undertake to:

- 1) fully carry out the activities as proposed in **Project #3** and **Project #4** also **in compliance with the regulations to contain infectious transmission**;
- 2) print at least 400 copies of the record produced in CD or vinyl or at least 400 copies between CD and vinyl;

- 3) send to the Puglia Sounds Press Office via Matteo Imbriani, 67 - 70121 Bari, 10 copies of the CD or vinyl produced, **within 5 days before the date of publication-launch**, in order to allow the promotion of the new release by Puglia Sounds Press Office;
- 4) produce at least one promotional video clip within 2 months from the date of the release and, in any case, for record releases by 31 July 2022 at the latest by 31 August 2022; **Please note that, where the same artistic project is submitted under the "Puglia Sounds Producers 2022" Call, the video clip produced cannot be the same as the multimedia production included in the Applicant's duties under the "Puglia Sounds Producers 2022" Call.**
- 5) send **within and no later than 15 days before the date of publication-launch on the digital platform and/or publication/launch of the cd or vinyl of the new release to certified (PEC) address PEC pugliasounds.record@pec.it the Final Communication and Promotion Project, which must be drawn up on the basis of the form provided by Puglia Sounds - TPP and must be in line with the one included in the project proposal (Project#3) and be implemented in all its parts.** Puglia Sounds – TPP is hereby allowed to either reduce the established amount of money or terminate the contract if the variation in question results in a lower quality of the project compared to the one proposed in the project;

- 9) use the hashtags **#WeAreinPuglia**, **#PugliaSoundsPlus**, in the communication on the social media related to project proposed;
 - 10) upload the new release on at least one digital distribution platform;
 - 11) publish the video clip on at least one digital platform;
 - 12) send photos of the artist/group (n.2 high-resolution 300 dpi photos, one vertical and one horizontal), social contacts (facebook, instagram, youtube etc.) 15 days before the publication/launch date to the Puglia Sounds communication office at paola.troia@pugliasounds.it;
 - 13) set up of a press office and/or social media management and/or Digital Strategy services, aimed at providing maximum visibility and promotion, on the media and social networks, of the project hereunder;
 - 14) include in the media communications and press releases (press, radio, television and web) regarding the project proposed, the wording "Programmazione Puglia Sounds Record 2022" accompanied by the wording **OPERAZIONE FINANZIATA A VALERE SUL POC PUGLIA 2007-2013 - AZIONE "SVILUPPO DI ATTIVITÀ CULTURALI E DELLO SPETTACOLO"** ("ACTION FUNDED BY POC PUGLIA 2007-2013 DEVELOPMENT OF PERFORMING ARTS AND CULTURAL ACTIVITIES"); in order to give adequate visibility through the Puglia Sounds - TPP channels. Before being sent to the media, these communications and materials must be agreed upon with the Puglia Sounds Press Office and then be sent to the e-mail address luciano.rutigliano@pugliasounds.it;
 - 15) **submit all the documents required for the settlement of the consideration as specified in Section 11 'Payment Modalities' below.**

Partial or complete failure by the Applicant to fulfill one or more of the obligations indicated above will at any time result in either a reduction in the amount of consideration or termination of the contract subscribed to with Puglia Sounds-TPP.

Total failure to fulfil the obligations of the Applicant under this contract will result in the termination of the contract.

Puglia Sounds-TPP reserve the right take action and at any time carry out checks, even test-checks, regarding **i)** the authenticity of the documents presented, **ii)** the truthfulness of the statements submitted by the Applicant and/or **iii)** the actual occurrence of the activities/events envisaged by the project covered by the contract subscribed to with the Applicant, by asking to be submitted additional documents and/or original documents attesting to the truthfulness of the statements submitted. Puglia Sounds – TPP undertake to communicate in writing the deadline for submission of any additional documents.

The amount defined in the Agreement will be paid within 30 days from the receipt of all the relevant documentation hereunder indicated:

(within and no later than 15 days of the implementation of all the activities planned and in any case no later than 31 August 2022) :

- a) Demand for Payment Form;
